Pursuant to the provisions of Sections 617.1001 through 617.1006 of the Florida Statutes, the undersigned not-for-profit corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: GLOBAL DIALOGUE, INC.
2. The Document Number of the corporation is: N15000011814
3. The Articles of Incorporation are hereby amended by deleting Article I in its entirety and substituting therefor the following:

Article I
NAME

The name of the corporation shall be THE KILLIDAR FAMILY FOUNDATION, INC. (hereinafter called the "Corporation").

4. The Articles of Incorporation are hereby further amended by deleting Section 1, Purposes, of Article III, Purposes and Restrictions, in its entirety and substituting therefor the following:

Section 1. Purposes. The Corporation is a not-for-profit corporation that is organized and shall be operated exclusively for religious, charitable, scientific, literary, or educational purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding subsequent federal tax law (the "Code"), and not for pecuniary profit.

5. The Corporation has no members; the foregoing Amendment was adopted by the Board of Directors of the Corporation on November 11, 2016, in the manner prescribed by Sections 617.0821 and 617.1002 of the Florida Not For Profit Corporation Act.
