ARTICLES OF INCORPORATION

OF

AXIPA-POUCHERS, INC.(Not for Profit Florida Corporation)

ARTICLE ONE NAME

The name of the corporation is AXIPA-POUCHERS, INC.

ARTICLE TWO PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation is: 178 North Roscoe Boulevard, Ponte Vedra, Florida 32082. This also the mailing address of the corporation.

ARTICLE THREE PURPOSE

The purpose for which the corporation is organized is to inspire and/or direct most of the needs and/or wants concerning the Axipa Poucher(s) as to the many forms, numerous applications and other Fashion & Function possibilities.

The corporation is organized exclusively for charitable and educational purposes, within the meaning of Section 501 (c)(3) of the Internal Revenue Code, as may be amended.

Upon the dissolution of the organization, assets shall be distributed for on or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Cod, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization in then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.)
