# **ARTICLE III**

#### **PURPOSE**

#### **OUR PURPOSE**

TR'S ROUGH RIDERS CAMPS CORP. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

TR'S ROUGH RIDERS CAMPS CORP. Purpose is to make the USA a natural paradise by purchase and accepting gift of rural acreage, waterways, lakes, etc. that has been physically abused by mankind in its pursuit of wealth at the cost and devastation of Mother Nature's Gifts of such a great land as the USA.

To teach to our Students, who upon graduation will be known as Cadets that the USA is our country and that we must cherish its natural wonders, cherish its natural resources; cherish all of Mother Nature's Bounty as our sacred heritage, for ourselves, our children and for eternity. To not let selfish mankind in the form of business, Politics, convenience or other greedy interests destroy our country of its beauty, its riches and wonderment. To accomplish this by holding hands-on classes lasting 21 and 28 days at TR'S ROUGH RIDERS CAMPS which are to be held in the very rural wilderness areas that were purposely purchased or donated in an abused condition.

#### **ARTICLE IV**

#### **NON-PROFIT NATURE**

#### 4.01 Non-profit Nature

TR'S ROUGH RIDERS CAMPS CORP. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of TR'S ROUGH RIDERS CAMPS corp. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

TR'S ROUGH RIDERS CAMPS CORP. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

#### 4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of TR'S ROUGH RIDERS CAMPS CORP. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

#### 4.03 Dissolution

Upon termination or dissolution of the TR'S ROUGH RIDERS CAMPS CORP. any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the TR'S ROUGH RIDERS CAMPS CORP. hereunder shall be selected by the discretion of a majority of the managing body of the TR'S ROUGH RIDERS CAMPS CORP. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the TR'S ROUGH RIDERS CAMPS CORP. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State where TR'S ROUGH RIDERS CAMPS CORP. ends up putting is headquarters.

#### 4.03 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

#### 4.04 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.05 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE V**

#### **BOARD OF DIRECTORS**

#### 5.01 Governance
