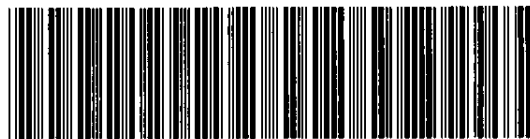

Pursuant to Title XXXVI, Chapter 605, Section 1025 of the Florida Revised Limited Liability Company Act, each of the undersigned merging entities executed the following Articles of Merger:

FIRST: The name of the surviving corporation is Florida Christian Homes Senior Housing, Inc., a Florida not for profit corporation with Document Number N15000012043, and the name of the company being merged into this surviving corporation is Water's Edge of Bradenton, LLC, a Florida limited liability company with Document Number L04000012615.

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed, and acknowledged by the surviving corporation and the merging company in accordance with the provisions of Sections 605.1021-605.1026 of the Florida Revised Limited Liability Company Act and Sections 617.1101-617.1108 of the Florida Not For Profit Corporation Act, and by each member of such limited liability company who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Florida Revised Limited Liability Company Act.

THIRD: The articles of incorporation of the surviving corporation on file with the Florida Department of State shall be the articles of incorporation of the surviving corporation.

FOURTH: The surviving entity agrees to pay any members with appraisal rights the amount to which such members are entitled under the provisions of Sections 605.1006 and 605.1061-605.1072 of the Florida Revised Limited Liability Company Act.

FIFTH: The merger is to become effective on the date of filing.


SIXTH: The Agreement and Plan of Merger is on file at the principal place of business of the surviving corporation.

SEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any member of the surviving corporation or member of the merging limited liability company.
