


Maranatha Church, PSL Inc. shall exist perpetually until dissolved by due process of law, and in keeping with the minutes of the Church of God International.

**ARTICLE 1X: DISSOLUTION OF ASSETS**


Upon dissolution, all assets will be received and administered by the Church of God regional office as set forth in the Minutes of the Church of God International.
