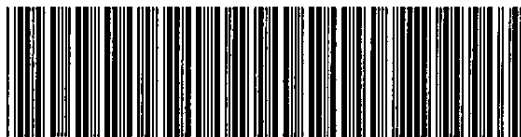

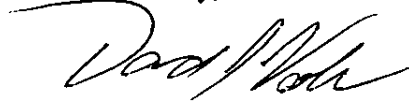

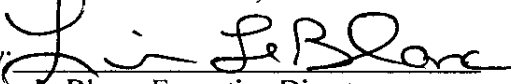

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is ShareSpace Foundation, Inc. The Federal Employer Identification Number is 54-1897591 and this number will not change.

**ARTICLE II**

The street address of the principal office of the Corporation is 8700 Astronaut Blvd., # 1048, Cape Canaveral, Florida 32920.

**ARTICLE III**

The purpose of the Corporation is to engage in any lawful act or activity for which non-profit corporations may be organized under the laws of State, and more specifically, be organized, and operated to assist the United States in addressing science literacy by igniting children's passion for science, technology, engineering, arts and math (STEAM) through delivering hands-on activities and inspirational messages. Such assistance shall further include facilitating programs to educate the general public concerning the fields of science and technology in general and space exploration in particular.

**ARTICLE IV**

The manner in which the directors are to be elected or appointed is stated in the Corporation bylaws.

**ARTICLE V**

The initial street address of the Corporation's registered office is 8700 Astronaut Blvd., #1048, Cape Canaveral, Florida 32920. The initial registered agent for the Corporation at that address is Linn LeBlanc, Executive Director.

**ARTICLE VI**
