ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

FILED W. 27 THE CHRISTIAN & MISSIONARY ALLIANCE CHURCH OF FORT LAUDERDALE, INC.

Pursuant to Section 617.1006 of the Florida Not-For-Profit Corporation Act (the "Act"), The Christian & Missionary Alliance Church of Fort Lauderdale, Inc., a not-for-profit Florida corporation (the "Corporation") filed with the Department of State on May 27, 1986, Charter Number N-15094 hereby makes these Articles of Amendment to its Articles of Incorporation as follows:

- The name of the Corporation is The Christian & Missionary Alliance Church of Fort Lauderdale, Inc.
- Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

"ARTICLE I

CORPORATE NAME

"The name of Corporation shall be: FIRST ALLIANCE CHURCH OF FORT LAUDERDALE, INC., a Florida not-for-profit corporation with its principal address at 900 Southwest 31st Avenue, Fort Landerdale, Florida 33312".

- In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
- The foregoing amendment was adopted by a unanimous vote of the members of the Board and all of the members of the congregation of the Corporation held at a meeting on July 6, 1997.
