ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ASCOT PROPERTY OWNERS' ASSOCIATION. PARTICLES OF STATE ASSOCIATION. PARTICLES OF STATE ASSOCIATION.
