To Whom It May Concern:

I am the President and Registered Agent of the Heartland Dog Club, Incorporated of Florida. I am applying for reinstatement of the corporation.

I moved on July 15, 2003, from 3940 Skipper Road, Sebring, Florida 33875, to 1601 Sunset Drive, Sebring, Florida 33870. This was after filing of the 2003 corporation report. I submitted a change of address with the post office in Sebring. At that time, the county was changing street names to comply with state 9-1-1 directives. SUNSET Drive was to change to Spirit Drive. However, the county then rescinded the directive. BUT, this did not precede someone in a county department sending a disk of the *proposed* street name changes, but **NOT** the *approved* names to the US Postal Service. [Enclosed is the form from the county notifying me of my correct and never changed street name.]

Meanwhile, for a period, the post office indiscriminately returned mail addressed to either of these addresses to the senders. It has been a nightmare! I have not received any notice(s) regarding the filing of the Corporation's Annual Report for either 2004 or 2005.

The lack of paperwork regarding the Annual Report came to my attention during the past week. I received a request to complete the Annual Report for the Highlands County Community Coalition for Substance Abuse Reduction (of which I am also President). Subsequently, I called your office and spoke with Michelle.

Because of the above-stated reasons and explanations, I am requesting that the Florida Department of State waive the reinstatement fee (\$175) for the Heartland Dog Club, Inc. of Florida (HDC). I have enclosed a HDC check for \$122.50 for the 2004 and 2005 Annual Reports with a Corporation Reinstatement form.

Thank you in advance for your attention and consideration of this request. Please advise if this is acceptable.
