Annual Members' Meeting Minutes November 8, 2001

MEMBERS PRESENT: John Baum, Aldo Del Tedesco, Philip Krombach, Marilyn Krombach

Meeting was called to order by Philip Krombach, President at 5:03 p.m. John Baum moved to pass on the reading of last years's minutes and accept as is. Aldo Del Tedesco seconded and approved by all.

The treasurer's report was reviewed and moved to be approved by all present.

Phil Krombach reported on the past years progress as follows: Curb widening was not contracted and still needs to be addressed. The scheduled roof repair for January, 2001 was not completed, the contractor never showed up or answered calls. We have new quotes to be presented. A water leak was found behind unit #600 and was repaired. Water bills are now back to normal. Greenlife Total Lawn & Garden Care was replaced by Don Howell who is now taking care of our landscaping. An amount for landscaping shrub replacement needs to be voted on. The gutters were cleaned in August by Gutter Clean for \$180.00. The septic tank was cleaned in September for \$210.00. Jennings now Waste Management was contracted for the next 3 years with a 7% cap annual increase. Contract price is \$190.00 per month, previous contract was \$272.60 per month. An electrical repair was made to electric line near the septic system for \$45.00.

ROOFING REPAIRS

Three separate quotes were presented for review ranging from \$5000.00 to \$15,000.00 with a variance of work to be done. John Baum is contacting another roofing contractor for one additional quote. When all information is compiled you will be contacted for final approval.

OTHER DISCUSSION

The rain water output form the gutter on the west rear side of the building is causing wash out and running onto the adjacent property and a complaint has been made to have it fixed. Aldo Del Tedesco is going to make arrangements to correct the problem by putting in gravel and a tee to divert the amount of water output. The

estimated cost is \$200.00 approx.

Affectments 15307/613009

It was suggested by Phil Krombach to start collecting Association fees on a quarterly bases as of January, 2002. Aldo Del Tedesco made motion to pay quarterly dues in advance. Motion was seconded by John Baum and approved by all.

A motion was made by Marilyn Krombach to approve a contract from A-1 Orange Cleaning Services Co. to clean the outside windows monthly for \$ 30.00 per month. Motion was seconded by John Baum and approved by all.

It was suggested to set aside money from the checking account into a savings fund specifically for roofing repair, for tax purposes and to negate the need for a special assessment to all owners. Philip Krombach made a motion to get a savings account started. Motion was seconded by Aldo Del Tedesco and approved by all. The accountant will be contacted as to how to properly allocate funds.
