Pursuant to §617.1002 and §617.1007 of the Florida Not for Profit Corporation Act, the undersigned Corporation, Unity Truth Center of Brandon, Incorporated, (the "Corporation"), pursuant to a two-thirds (2/3) vote at a membership meeting and in accordance with the Bylaws, effective June, 1991, hereby adopts the Amended (all Articles are amended hereby) and Restated Articles of Incorporation (the "Amendment") set forth below. The membership of the Corporation entitled to vote on the Amendment approved and adopted these Amended Articles of Incorporation, which adoption was effected for corporate purposes on January 28, 1996. These Articles of Incorporation, as completely amended and restated, supersede the original Articles of Incorporation.

ARTICLE ONE

NAME: The name of the Corporation is Unity Christ Church, Incorporated. The principal place of business and mailing address of the Corporation shall be 1911 North Gordon Street, Plant City, Florida 33566.

ARTICLE TWO

DURATION: The term of existence of the Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles with the Secretary of State.

ARTICLE THREE

PURPOSE: The purposes of the Corporation shall be the support of public worship by the maintenance of a center building and the preaching and teaching of Practical Christianity as interpreted by the Unity School of Christianity, Unity Village, Missouri; the holding of classes for instruction in the principles of said Practical Christianity; and the conducting of Sunday School classes and instruction in said Practical Christianity.

To have all powers that may be conferred upon Corporations formed under Florida Statutes, Chapter 617.

AUTHORIZED RESIDENT AGENT: UNITY CHRIST CHURCH, INCORPORATED, a Florida not-for-profit corporation, hereby acknowledges that Doreen Begley-Rife, 11216 Garfield Court, Seffner, Florida 33584 is designated as the Resident Agent for UNITY CHRIST CHURCH, INCORPORATED, a corporation not-for-profit incorporated under Florida Statute §61.7.

Legal Process may be served upon UNITY CHRIST CHURCH, INCORPORATED by serving Doreen Begley-Rife, 11216 Garfield Court, Seffner, Florida 33584.

ARTICLE SIX

DIRECTORS: The business and affairs of this Corporation shall be managed by a Board of Directors whose members are referred to herein as Directors. The number of Directors of the Corporation may not be less than six (6). The number of Directors, so long as not less than six (6), may be changed from time to time as provided in the Bylaws. Directors shall be elected, removed and hold office as provided in the Bylaws. Effective upon the filing of these Amended and Restated Articles of Incorporation, the names and addresses of the persons who are to serve as the Directors until their successors have been duly elected and qualified are:
