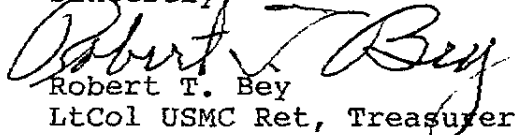
Per your instructions in the referenced letter the attached Articles of Amendment for the former Flagler County Chapter, The Retired Officers Association is submitted for file.

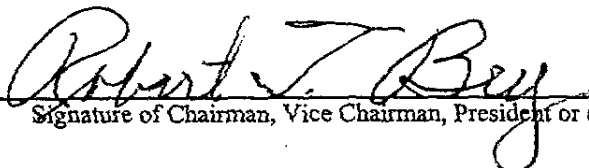
