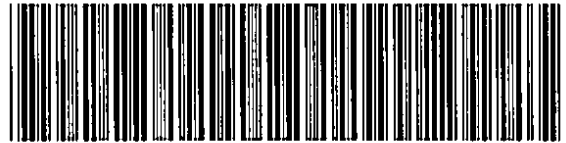

The Board of Directors of Institute for Holistic Education (the Institute) met to discuss the final resolution and dissolution of the Institute.

The filing of the Articles of Dissolution was mailed to the Division of Corporations upon completion of Institute charitable contributions in March/2019 with a check in the amount of \$43.75 to purchase a certified copy of the dissolution for IRS filing, effective April 30, 2019.


The 2017 Form 990-PF was filed timely with IRS on January 14, 2019 with a check in the amount of \$62 for 2017, \$59 for 2016 and approximately \$191 for 2018. The final 2018 Form 990-PF will be filed upon receipt of the certified copy of the dissolution from the FL Division of Corporations.

There are no known debts of the Institute.

Secretary, Jetta Goolsby, has sold all securities and transferred all funds from Wells Fargo brokerage to Wells Fargo checking for payment of final disbursements. \$25,000 of the remaining balance of Wells Fargo checking will be donated to Blue Wave After School Inc, 59-3729588, a 501(c)(3) serving youth in the Micanopy and Gainesville, FL area. PK Yonge is the University of Florida teacher training school that is responsible for the Blue Wave After School program. The remaining balance of \$7,017.02 will be donated to Unity of Gainesville, Inc. (a 501(c)(3) religious nonprofit organization located at 8801 NW 39th Ave, Gainesville, FL 32606, based on the wishes of deceased executive director, Walter Busby upon confirmation and acceptance from the Unity of Gainesville Board of Director to create a library and source guide for the ascendance of the planet earth..
