Article IX - 4 Lucky Dogs Pet Rescue, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article X - No part of the net earnings of 4 Lucky Dogs Pet Rescue, Inc. shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the non-profit corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Articles of Incorporation. No substantial part of the activities of the non-profit corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the non-profit corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaignon behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the non-profit corporation shall not carry on any other activities permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a non-profit corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article XI - Upon the dissolution of 4 Lucky Dogs Pet Rescue, Inc., its assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, for exclusively to such organization or, as said Court shall determine, which are organized and operated exclusively for such purposes.
