

# ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. For charity exclusively within the meaning of Section 501 (c) (3)
- B. Notwithstanding any other provisions of these articles the Corporation shall not carry on any other activities not permitted to be carried on:
  - By a Corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code; or
  - ii. By a Corporation contributions to which are deductible under Section 170 (c) (3) of said Code or the corresponding provisions of any future statute of the USA.
- C. No substantial part of the activities of the Corporation shall consist of propaganda or otherwise attempting to influence legislation; nor shall the Corporation participate or intervene in any political campaign (including the publishing of statements on behalf of any candidate for public office.
