Amend Article III to be:

Friends of Bluewater Bay Corp. is a non-profit corporation, organized exclusively for charitable purposes, including for such purposes as the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Projects and activities will support the more defined purpose of flood mitigation the Bluewater Bay community, to support other projects and/or amenities that advance the welfare and/or prevent the deterioration of the community. Also, to supplement government funds for the repair, maintenance, and improvement of common area infrastructure and amenities to lessen the burden of government.

Add Article IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to the Friends of Bluewater Bay Corp. then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the MSBU of Bluewater Bay to be added to the general fund.
