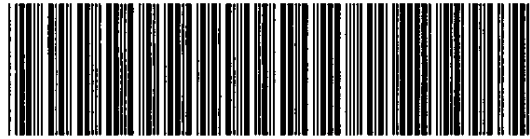

# NONPROFIT CORPORATION ARTICLES OF INCORPORATION

Pursuant to §617 of the laws of Florida, the undersigned majority of whom are citizens of the United States, do hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation.

## ARTICLE 1

### Name

The name of the corporation is: Logos Partnership International, Inc.

## ARTICLE 2

### Existence

#### **Section 1. Nonprofit Purpose**

The corporation is organized and shall be operated exclusively for religious and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The specific purposes and objectives of the corporation shall include, but not be limited to, the following: To be a Christ-centered organization that exists to support churches in Cuba with strategic alliances to meet the mission of bringing transformation and wellbeing of individuals, families and entire communities. That Logos Partnership International be positioned between churches and organizations as a bridge to bring them awareness about the reality of Cuba and to connect them with churches and ministries in Cuba who share their vision and values. Also, to generate ways to build partnership and develop projects, ensuring that resources are channeled and managed properly.

The corporation shall have perpetual existence.

#### **Section 2. Specific Purpose**

- Logos Partnership International exists primarily to equip and train strategic leaders and Pastors through dynamic and transformational training, using informal programs that combine education with mentoring in the context of actual ministry.
- We seek to inspire and empower churches to be agents of transformation in their specific context. Equip and advise them in their work of biblical-theological education and training of their members.
- Provide technical advice, supervision, and financial support to projects of churches and ministries in Cuba that arise from their own local initiative and that aim to respond to the needs and problems identified in their communities.
- Raise and channel funds and mobilize human resources and materials in order to support the LOGOS program, the forms of support include financing and participating in projects or donating to the administrative and organizational operations. We seek to create partnerships with Christian and humanitarian organizations that desire to work in Cuba and that would contribute financially to LOGOS Partnership International. In search of economic self-sufficiency, the ministry will promote and support small businesses in Cuba and manage other sources of income from the United States.


