

Article III - Purpose, shall be amended as follows:

**ARTICLE III - PURPOSE -**

The specific purpose for which this nonprofit corporation is organized is to assist the City of St. Augustine Beach and St. Johns County, Florida, in the renovation of the recreational facilities at Ron Parker Memorial Park and the addition of a "skate park" to be used by the general public for recreational activities such as skateboarding.

Said organization is organized exclusively for charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

Article IX - Dissolution, shall be amended as follows:

**ARTICLE IX - DISSOLUTION -**

Upon dissolution of the organization, assets shall be distributed from one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


