**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
WOLFSON CHILDREN'S HOSPITAL OF JACKSONVILLE, INC.**

A. The name of the corporation is Wolfson Children's Hospital of Jacksonville, Inc. (the "Corporation").

B. An amendment to the Articles of Incorporation, as set forth below, was adopted on March 6, 2018, by the sole Member and Board of Directors of this Corporation, pursuant to Sections 607.1001 and 607.1002, Florida Statutes (2017).

C. Article IV of the Articles of Incorporation is amended in its entirety to read as follows:

**"ARTICLE IV
MEMBER**

The Corporation's Member shall be Southern Baptist Hospital of Florida, Inc."


D. There are no other amendments to the Articles of Incorporation, except as stated above.
