Pursuant to and in compliance with Chapter 617,0202, F.S. these articles of incorporation are set forth:

Article I:

The name of the corporation shall be: Sacred Heart Franciscan Community & Outreach, Inc. (Hereafter known as "The Ministry")

Article II:

The Community shall maintain in the State of Florida a registered office and a mailing address as: 469 S.W. Seaflower Terrace
Port Saint Lucie, FL 34984

Article III:

The period of its duration is perpetual. The qualification for members and the manner of their admission shall be regulated by our Rule of Life (A.K.A. bylaws).

Article IV:

Purpose: The specific purpose for which the corporation is organized is to establish and maintain a Franciscan Ministry.
