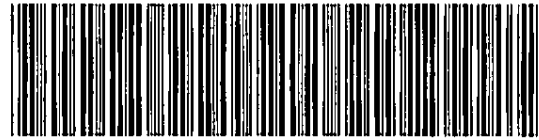

If dissolved, pursuant to a plan adopted by the board of directors, assets shall be transferred or conveyed to one or more corporation, society, or organization that qualify as exempt organizations under section 501(c)(3) and are engaged in activities substantially similar to those of the corporation.


