ARTICLES OF INCORPORATION

OF

New Creation International Ministries, Inc.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a non-profit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of New Creation International Ministries, in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

ARTICLE I NAME

New Creation International Ministries, Inc.

(Hereinafter a non-profit corporation) EIN: 81-0791177

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The principle place of business of the corporate office is located at 415 Citrus Tower Blvd., Clermont, FL 34711

The property and assets of this corporation are irrevocably dedicated to Charitable, Religious, Educational and Literary purposes.

ARTICLE III PURPOSE

The purpose of New Creation International Ministries, is established to provide humanitarian assistance to orphans, homeless and disadvantaged citizens of Kampala Uganda, and to provide the economically and technologically disadvantaged citizens in Uganda and other countries with training to help improve their quality of life. The organization is organized exclusively for charitable, religious, educational and literary purposes under the Internal Revenue Code section 501(c) (3).

Notwithstanding, any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under Section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code.

The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers or Members thereof, or to any individual except as reasonable compensation for services actually performed in carrying out the Corporation's Charitable and educational purposes. The property, assets, profits and net income of the corporation are irrevocably dedicated to charitable, literary and educational purposes, and no part which shall inure to the benefit of an individual.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
