# ARTICLES OF INCORPORATION OF THE AUTISM CHANNEL FOUNDATION, INC.

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida as follows:

# ARTICLE I Name, Principal Place of Business, and Mailing Address

The name of the Corporation is The Autism Channel Foundation, Inc., (hereinafter called the "Corporation") with the principal place of business located at 5401 North Haverhill Road, Studio 119, West Palm Beach, FL 33407.

# ARTICLE II Term of Existence

The date when corporate existence commenced was the date of the filing of the initial articles of incorporation by the office of the Florida Department of State and the Corporation shall have perpetual existence thereafter.

# ARTICLE III Purpose

The Corporation is organized and shall be operated exclusively for charitable and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), including, but not limited to, supporting the production and broadcast of special educational programs geared toward those interested in and/or affected by autism spectrum disorders, as well as providing financial grants and making charitable contributions to benefit and assist non-minor individuals on the autism spectrum with earning an income or living independently.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

# ARTICLE IV Members

The Corporation's membership shall be as set forth in the Corporation's bylaws.

# ARTICLE V Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 5401 North Haverhill Road, Studio 119, West Palm Beach, FL 33407 and the name of its initial registered agent at such address is Ray Smithers.

#### ARTICLE VI Directors

The Corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the Corporation, provided that the Corporation shall always have at least three (3) directors.
