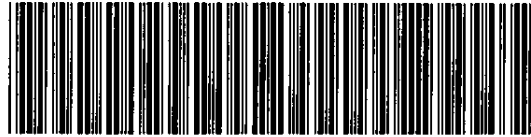



# **ARTICLES OF INCORPORATION OF JEFFERSON DIAPER BRIGADE, INC.**

The undersigned, all of whom are citizens of the United States, desiring to form a non-profit corporation under the provisions of Chapter 617, Florida Statutes, do hereby certify:

## **ARTICLE I**

### **NAME**

The name of this Corporation shall be the **JEFFERSON DIAPER BRIGADE, INC.** The business of the Corporation may be conducted as the JEFFERSON DIAPER BRIGADE, INC.

## **ARTICLE II**

### **LOCATION**

The place where the principal office of the Corporation is to be located is 1540 Live Oak Road, in the City of Monticello, Jefferson County, Florida.

## **ARTICLE III**

### **PURPOSE**

The JEFFERSON DIAPER BRIGADE, INC. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The JEFFERSON DIAPER BRIGADE, INC. will gather donations of disposable diapers, or cash/grant donations with which to purchase disposable diapers, for distribution through food pantries and religious organizations located in Jefferson County, Florida, to the indigent population in the area.

## **ARTICLE IV**

### **BOARD OF DIRECTORS**

The JEFFERSON DIAPER BRIGADE, INC. will be governed by a Board of Directors, appointed as stated in the Corporation's bylaws.

## **ARTICLE V**

### **DIRECTORS/OFFICERS**

The management of the affairs of the Corporation shall be vested in its officers, none of whom shall receive compensation for duties performed.

## **ARTICLE VI**

### **NON-PROFIT NATURE**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
