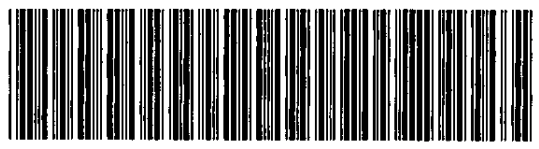

**ARTICLES OF INCORPORATION  
OF  
THE THOMAS G. TERCILLA  
NEUROLOGICAL RESEARCH FOUNDATION, INC.**

**ARTICLE I  
Name**

The name of the corporation is ~~The~~ Thomas G. Tercilla Neurological Research Foundation, Inc. (the "Foundation").

**ARTICLE II  
Principal Office**

The address of the principal office and the mailing address of the Foundation is 6770 SW 74<sup>th</sup> Street, South Miami, FL 33143

**ARTICLE III  
Purpose**

The purpose of the Foundation is to provide funding for neurological research institutions, aid in the development of neurological science, and honor the memory of Thomas George Tercilla, and to conduct all such matters exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

**Limitations of Purpose:**

No part of the net earnings of the Foundation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this Foundation is irrevocably dedicated to fulfilling the purpose set forth above, and no part of the net income or assets of this Foundation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this Foundation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Foundation.

Upon the dissolution of the Foundation, assets shall be distributed for one or more

exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**ARTICLE IV**  
**Manner of Election or Appointment of Directors**

All elections or appointments shall be made in the manner set forth in the Foundation's By-Laws.
