ARTICLES OF INCORPORATION

The articles of incorporation of First United Methodist Church of Port St. Joe, Jinc, Tartad are as follows. Incorporated are as follows.

## ARTICLE I - NAME

The name of this corporation is First United Methodist Church of Port St. Joe, Inc, (hereafter referred to as "FUMC").

#### ARTICLE II - PRINCIPAL OFFICE ADDRESS

The principal place of business and mailing address of this corporation is at 1001 Constitution Drive, Port St. Joe, Florida 32456. The registered agent of this corporation at that address is GEOFFREY LENTZ.

#### ARTICLE III – TERM & PURPOSE

This corporation shall have perpetual existence and its commencement shall be effective from date of filing.

FUMC is a nonprofit religious corporation. It is organized as a local United Methodist Church exclusively for religious purposes, supports the doctrine of the United Methodist Church, and declares itself and all of its property subject to the law, usages and ministerial appointments of the United Methodist Church.

The Corporation is to be operated exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of its charter, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 © (3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170 ( C ) (2) of the Code, or corresponding section of any future tax code.

## ARTICLE IV-DIRECTORS/BOARD OF TRUSTEES

The Directors of FUMC shall be the Board of Trustees who shall be elected in accordance with the By-laws and The Book of Discipline of the United Methodist Church.

#### ARTICLE VIII - CORPORATE MEMBERSHIP

The corporation shall have members. Upon the filing of these Articles of Incorporation, the members of the former unincorporated local First United Methodist Church of Port St. Joe, Florida shall be members of this corporation. Only those members of the FUMC who are members of the Charge Conference, as defined in the Book of United Methodist Church (hereinafter "the Discipline"), are entitled to vote at a meeting of the members; provided, however if the District Superintendent convenes a Charge Conference as a Church Conference, all members of the Corporation present shall be entitled to vote.

#### ARTICLE IX - POWERS

The business of this corporation shall be conducted in conformity with the Discipline as the same now exists or as may be hereafter amended, changed or modified, and the bylaws shall include the Discipline and no bylaws shall be adopted inconsistent with the provisions of the Discipline.

In addition to the powers and duties granted herein and by the Discipline, FUMC assumes for itself all the rights, powers, and privileges and immunities which are now, and which may be during the existence thereof be conferred by law upon corporations with a similar character, provided the same are not inconsistent with the Discipline.

#### ARTICLE X - TERM

The FUMC shall exist in perpetuity. If for any reason FUMC shall be abandoned, discontinued, or cease to exist as a legal entity and its charter shall expire or be terminated, the title to all of its property shall be vested in a be the property of the Alabama West Florida Annual Conference of the United Methodist Church, pursuant to the Discipline, provided it is then an organization qualified under Section 501 (C) (3) of the Internal Revenue Code.

IN WITNESS WHEREOF, we the undersigned subscribing incorporator has hereunto set his hand and seal this 2/5/day of January, 2016, for the purpose of forming this Corporation, not for profit, under the laws of the State of Florida and I hereby make and file in the office of the Secretary of State, State of Florida, these Articles of Incorporation and certify that the facts herein stated are true.
