### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FAGO FAMILY FOUNDATION, INC., a Florida not-for-profit corporation

Pursuant to the provisions of sections 617.1001, 617.1002 and 617.1006, Florida Statutes, FAGO FAMILY FOUNDATION, INC. adopts the following amendment to its Articles of Incorporation:

FIRST: The name of the corporation is FAGO FAMILY FOUNDATION, INC. (the "Corporation").

SECOND: Article V of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

### "ARTICLE V - INITIAL BOARD OF DIRECTORS

The Corporation shall have at least three (3), but no more than nine (9) Directors. The number of Directors may be increased or decreased from time to time in the manner provided in the Corporation's Bylaws, but shall never be less than three (3).
