ARTICLE VIII

DISSOLUTION

Any such assets no so disposed of shall be disposed of by a Sourt of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
