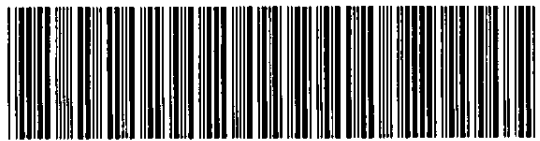

The undersigned hereby submits these Articles for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certifies as follows:

**ARTICLE I
Name**

The name of the corporation shall be QE Airpark Condominium Association, Inc., which corporation shall herein be referred to as the "Association", and whose initial principal place of business and mailing address shall be 3894 Mannix Drive, Suite 216, Naples, FL 34114-5406.

**ARTICLE II
Purpose**

The purpose for which the corporation is organized is for the operation and management of leasehold condominium hangar buildings and grounds for the operation of QE Airpark, a Condominium, located in Collier County, Florida, and any other purpose permitted under Florida law.

**ARTICLE III
Existence**




