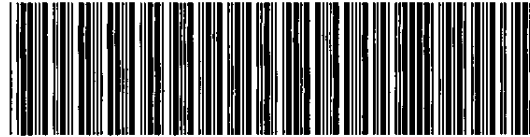

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporations Act, Florida Statute section 617 hereby adopts the following Articles of Incorporation.

I. Name

Name of the corporation shall be as follows as follows:

II. Purposes

1. Said hereinabove name corporation pursuant to provisions on Section 501 ( c ) ( 4 ) the Internal Revenue Code is a Social welfare organization, organized solely to conduct educational tours of historical sites that evidence connections to history that emanates from original Gullah Geechee African roots and are displayed along the U. S. National Park Service Gullah Geechee Corridor that extends from the state North Carolina to St. Augustine Florida.
2. To insure that all benefits, and assets that inure to the organization are will not inure to any individual but only for reinvestment in the operation of organizational Gullah Geehee tours activities.
3. Said organization shall utilize 20% of organizational time to for endorsement activates to support political candidates.
4. 30% of organizational time will be utilized to lobby for support of Gullah Geechee Chocolate Tours.

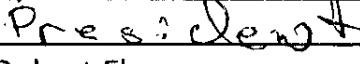
