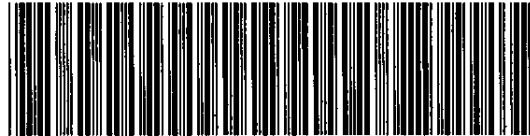

**ARTICLES OF INCORPORATION
OF
CITRUS COUNTY FAMILY VISITATION CENTER, INC.**

The undersigned, a citizen of the United States, for the purpose of forming a Florida Not-for-Profit Corporation, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **CITRUS COUNTY FAMILY VISITATION CENTER, INC.**

ARTICLE II: PRINCIPAL PLACE OF BUSINESS

The place in this state where the principal office of the Corporation is to be located is the City of Inverness, Citrus County, Florida. The mailing address of the corporation shall be: 110 North Apopka Avenue, Suite XXX, Inverness, Florida 34450.

ARTICLE III: DATE OF EXISTENCE

The existence of the corporation shall commence on February 9, 2016.

ARTICLE IV: PURPOSE

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purpose for which the corporation is organized includes, but is not limited to, developing a multi-faceted family visitation center to facilitate visitation, time-sharing, and family interactions by providing a structured visitation setting, educational opportunities, and other programs to address the varied needs of families and undertaking such activities which, in the discretion of the Board of Directors, may be calculated to further the above purpose, and, to that end, organizing and maintaining other educational, charitable or religious institutions or agencies.

ARTICLE V. NO EARNINGS TO INURE TO BENEFIT MEMBERS, ETC.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not

participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation shall not issue stock.

ARTICLE VI. DIRECTORS

The corporation shall have three directors or trustees initially. The number of directors or trustees may be increased from time to time, as provided for in the Bylaws of the corporation, but shall never be less than three. The names and addresses of the initial directors are:

ARTICLE VII. MEMBERSHIP

The names and qualifications for members of this corporation and the manner of their admission to membership shall be as regulated by the Bylaws.

ARTICLE VIII. INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial registered agent of the corporation is Jack A. Moring, and the initial registered agent's street address is 7655 W. Gulf to Lake Highway, Suite 12, Crystal River, Florida 34429.

ARTICLE IX. INCORPORATOR

The name and street address of the incorporator of the corporation is:

The incorporator assigns to the corporation all rights under section 607.0201, Florida Statutes.

ARTICLE X. BYLAWS

The Board of Directors of the corporation may adopt such Bylaws for the conduct of the activities and business of the corporation and the carrying out of its purposes as they may deem necessary from time to time. Upon proper notice, the Bylaws may be amended, altered or rescinded by a majority vote of those members of the Board of Directors present at any regular meeting of the Board of Directors or any special meeting of the Board of Directors called for that purpose.

ARTICLE XI. INDEMNITY

The corporation shall indemnify its officers, directors, managers, employees and agents to the fullest extent provided by law. The directors are hereby specifically authorized to make provisions for such indemnification of directors, officer, employees and agents.

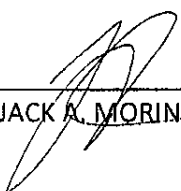
ARTICLE XII. DISSOLUTION

Upon the dissolution, liquidation or winding up of the corporation, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XIII. AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended in the manner set forth in section 617.1002, Florida Statutes.

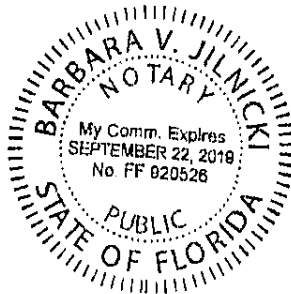

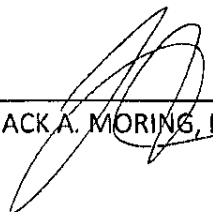

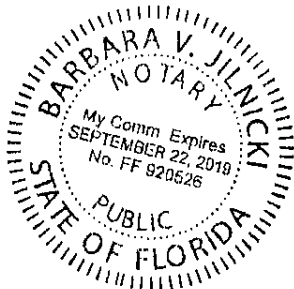
