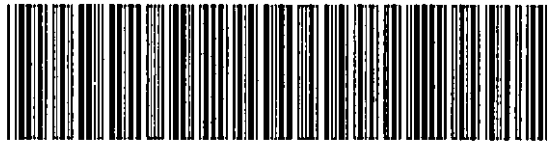

**AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF MYSTIQUE AT WATERPARK PLACE  
CONDOMINIUM ASSOCIATION, INC.**

BE IT HERE KNOWN THAT Mystique at Waterpark Place Condominium Association, Inc., a duly registered corporation not-for-profit organized under the laws of the State of Florida ("Association"), being officially registered February 26, 2016, under Document Number IN16000002060, files the following amendment to its Articles of Incorporation:

**WITNESSETH:**

WHEREAS, pursuant to Section 6.4 of the Declaration of Condominium of Mystique at Waterpark Place, a condominium (the "Declaration"), recorded in Official Records Book 5629, Page 3418, et seq., of the Public Records of Collier County, Florida, the Developer reserved the right (as long as the Developer owns at least one Unit), to unilaterally amend the Articles of Incorporation and the Bylaws of the Mystique at Waterpark Place Condominium Association, Inc. without requiring the consent of any Board member or Unit Owners, except as provided therein; and

WHEREAS, the Developer owns at least one Unit as set forth in Section 6.4 of the Declaration; and

WHEREAS, the Amendment made by the Developer to the Articles of Incorporation and Bylaws was recorded November 12, 2021 in Official Records Book 6040, Page 3846, of the Public Records of Collier County, Florida,

NOW THEREFORE, Consistent with the foregoing Amendment, the Association amends the Articles of Incorporation as follows [Additions indicated by underlining; Deletions indicated by ~~strike through~~]:

**Article 5, titled "POWERS", Section 5.2 subsection (g) and (h), of the Articles of Incorporation are hereby amended to read as follows:**

**5.2 Enumeration.** The Condominium Association shall have all of the powers and duties set forth in the Act, except as limited by these Articles, the By-Laws and the Declaration of Condominium (to the extent that they are not in conflict with the Act), and all of the powers and duties reasonably necessary to operate the Condominium pursuant to the Declaration of Condominium and as more particularly described in the By-Laws, as they may be amended from time to time, including, but not limited to, the following:

(Section (a) through Section (g) Remain Unchanged, Except as Provided Below)

(g) The power to adopt and amend rules and regulations concerning the details of the operation and use of ~~the Common Elements and the Condominium Association~~ Property and any Association Property.

(h) The power to acquire, convey, lease and encumber real and personal property. Personal property shall be acquired, conveyed, lease or encumbered upon a majority vote of the Board of Directors, subject to Article ~~40~~ 8 of the Declaration of Condominium. Real property (including, without limitation, any of the Units) shall be acquired, conveyed, leased or encumbered upon a majority vote of the Board of Directors alone; provided that the requirements of Article ~~40~~ 8 of the Declaration pertaining to the Unit Owners' approval of costs in excess of the threshold amount stated therein (including the proviso regarding the debt incurred) shall also apply to the acquisition of real property, including Units; provided, further, however, that the acquisition of any Unit as a result of a foreclosure of the lien for Assessments (or by deed in lieu of foreclosure) shall be made upon the majority vote of the Board, regardless of the price for same and the Condominium Association, through its Board, has the power to hold, lease, mortgage or convey the acquired Unit(s) without requiring the consent of Unit Owners. The expenses of ownership (including the expense of making and carrying any mortgage related to such ownership), rental, membership fees, taxes, Assessments, operation, replacements and other expenses and undertakings in connection therewith shall be Common Expenses.

**Article 10, titled "DIRECTORS" Section 10.1 of the Articles of Incorporation is hereby amended to read as follows:**

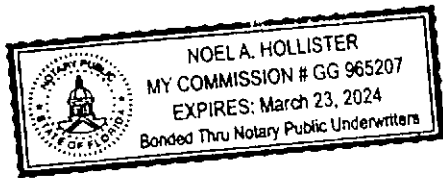
**10.1 Number and Qualification.** The property, business and affairs of the Condominium Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall initially consist of three (3) directors and ~~may~~ shall be expanded to five (5) persons at ~~or after~~ the Turnover Meeting.


