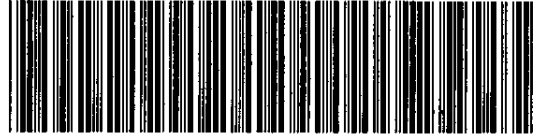

DISSOLUTION : Upon dissolution of WARRIORS FOR GOD CORPORATION, assets shall be determined & unanimously voted by the board of directors to be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

B. whether partnerships, joint ventures, and arrangements with management organizations conform to WARRIORS FOR GOD CORPORATION written conflict of interest policy, are properly recorded, reflect reasonable investment or payments for goods & services, further charitable purposes and do not result in inurement, impermissible private benefit or in an excess benefit transaction.

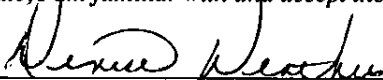

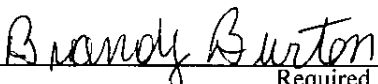
