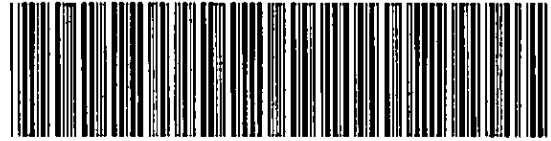

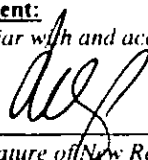

**Article III amendment.**

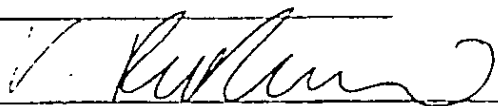
