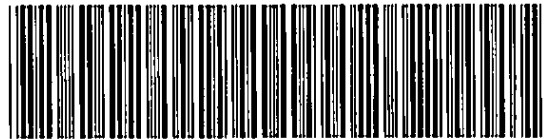

(1) TO AMEND ARTICLE iii; PURPOSE

Fessenden School Alumni Association Inc., is organized exclusively for charitable purposes, the making of distributions to organizations that qualify as exempt organizations described under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any further tax code.

(2) TO AMEND ARTICLE xii; Nonprofit operation/dissolution clause, section two (2) Dissolution Clause

Upon the dissolution of Fessenden School Alumni Association, Inc., assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county of Marion, state of Florida, exclusively for such purposes or to such organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
