Article 8 Replacement

A- VISION

Said corporation is organized exclusively for charitable, religious, educational, environmental, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax Code.

This organization is mainly aimed to establish and maintain a Church, provide a place of public worship, conduct bona fide charity work, support and further constructive science and green Theology, hold, take, manage, dispose and acquire through purchases or donations real and personal properties for organizational purposes, contribute to the betterment of the ecosystem, open and develop happy, caring and transformative community schools for the moro-mento-cerebro spiritual and professional transformation of the local communities, our common humanity, the planet earth, which is our common home, here in Florida, the United States, and around the world. To that end, the corporation may adopt and establish bylaws, rule and regulate necessarily and expediently in a lawful manner and harmony with these incorporation articles.

The corporation shall be authorized and empowered to help create a better, cleaner, healthier, safer, saner, and more united caring and loving eco-friendly world for all of us as human family and the generations to come by defeating poverty, hunger, diseases, immorality, and insanity, promoting a green Theology, reducing hyperbolic narcissism and exponential moro-physico spiritual carbon emissions accumulating in human's hearts, souls and minds demonstrated, reflected in the natural environment, preserving our common humanity, securing our common future, and transforming our common planet into a socio moro-cerebro-ecologico spiritual microcosm of the lost, promised and aspired biblical Eden as we journey together from Eden to Eden as one people and family under

God through Christ, the static and dynamic cause of our common planet and existence.

B- MISSION

The organization shall be empowered to help turn green this morally, mentally, socially, physically, spiritually, intellectually, and ecologically polluted world, so as to help create an Eden-like common society of brotherhood and sisterhood based on love, morality, spirituality and shared responsibilities where love, peace, harmony, justice, equal opportunity, healthcare, good education, the ecosystem, children, women, the elderly, the sick, the poor and every life and potential are valued, fulfilled, cherished, promoted, ______ protected and cared for. C- RELIGIOUS AND EDUCATIONAL PUBLICATIONS

The organization shall be authorized and empowered to publish and disseminate religious and educational related books, flyers, magazines, children school materials, and the like, as well as to obtain funds through collections, bequests, donations, and other just and legal necessary means for the moro spiritual and intellectual enlightenment of our common planet, and local communities.

D- CONSTRUCTIVE EVANGELISM

For its expansion and the crystallization of its mission and vision, the corporation shall recruit, train, and organize men and women from all walks of life to labor on behalf of the earth, which is our common home, every creature and human race, regardless of color and gender, particularly the most vulnerable ones, and more particularly the needy and destitute suffering women and children throughout the State, the nation and the world. The organization will cooperate with all and any lawful secular and religious institutions, societies or agencies rejecting violence, hate, and discrimination to enlighten the world, protect our common humanity, preserve the common earth, which is our common home, and ultimately meet the full rationale behind its existence as a nonprofit organization.
