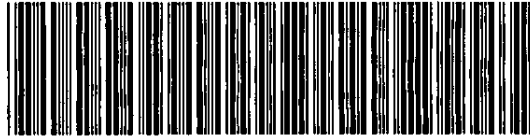

Article III is being ammended to read: This corporation is organized exclusively for charitable purposes within the meaning of the Internal Revenue Code Section 501(c)(3), namely: To establish and maintain a house of Chabad Lubavitch Orthodox Jewish worship for members of the Jewish faith, in and around Delray Beach FL, wherein will be performed religious education for men, women and children as well as other outreach activities and celebrations. All activities will be governed by the laws and traditions of Orthodox Judaism and Chabad Chassidism as understood by the corporation's Rabbi and Spiritual Leader, The Chabad Emisary, Shmuel Biston. This corporation will provide a parsonage for The Emissary and his family and will and will raise funds through membership dues, direct solicitation and other appropriate means. No part of this corporation's earning will be benefit any private person, unless is in the form of compensation paid to officers and religious teachers in the fulfillment of their duties, in the form of teaching, counseling and hospitality extended to congregents or as compensation paid to directors for losses resulting directly from the fulfillment of their duties. This corporation will not attempt to influence legislation in any way or intervene on behalf of any political candidate. Rabbi Shmel Biston is appointed by the World Leadership of the Chabad Chassidic Movement to serve in perpetuity as Emissary of the Chabad Movement to Delray Beach FL. Therefore his position as Spiritual Leader and President cannot be amended or altered. In the event of this corporation's dissolution all remaining assets will be distributed by the directors to other IRS 501(c)(3) recognized charitable organizations with similar purposes.


