Subject to the foregoing provisions and furtherance of its express purposes, the corporation has the following Mission:

Delivering Disciple's Inc. Outreach Center, mission is to promote youth motivation within males ages 10-16. With goals to prevent them from becoming "at-risk" while in this transitional stage. By providing gender specific programming and positive out of school activities which include motivational events, a strong leadership team, fostering a brotherhood, and social family structure.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which shall provide opportunities for involvement in said activities and programs in order to have a greater impact for change within our male youth.
