FIRST: <u>Name</u>. The name of the corporation is FLORIDA ALLIANCE FOR RECOVERY, INC.

SECOND: <u>Principal Office</u>. The mailing address and street address of the principal office of the Company is:

THIRD: <u>Duration</u>. The period of its duration is perpetual.
