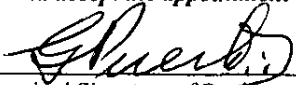

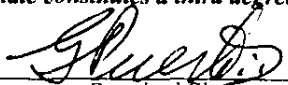

### Qualifications of Members and manners of Admission
