FLORIDA NOT-FOR-PROFIT ARTICLES OF INCORPORATION

In Compliance With Chapter 617, F.S.

AT THE MOVIES CORP.

The undersigned citizens of the United States, desiring to form a Florida Not For Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify

ARTICLE I: NAME

The name of the corporation shall be "At The Movies Corp."

ARTICLE II: PRINCIPAL OFFICE

The principal office of the Corporation is to be located is Delray Beach, Florida with principal street address: 16275 Vintage Oaks Lane, Delray Beach, Florida 33484.

ARTICLE III: PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Said corporation shall act to educate the public about the history of the United States film industry, especially those movies with themes featuring the fight against crime, corruption, and abuse (financial, physical and/or emotional). Said corporation's emphasis shall be on movies, however, media output from other segments of the entertainment industry may be considered.

ARTICLE VIII: NET EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene

in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.


Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
