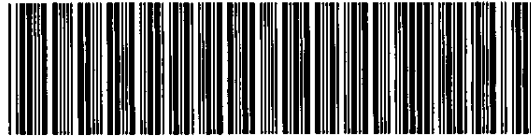

This letter is being written to clarify some of the concerns you expressed about the filing of our new Non-Profit Corporation, MOVING FORWARD TGTHR; specifically in reference to a potential typographical error in our name, the concern that our agency's name is not distinguishable from a recently dissolved/revoked entity and section 617. 0202(d)

Our Founders and Board of Directors intentionally removed the vowels from the word "together" because TGTHR represents a big part of our agency and branding. We plan to trademark the name as well, so the precise spelling is of the utmost importance. Based on research we conducted on Sunbiz.org, we feel that the spelling easily distinguishes our entity from others, either current or revoked/dissolved. If you still feel otherwise, please provide the name if the agency or contact me at the number or email below so we can remedy this situation.

Lastly, we have made the necessary corrections to section 617. 0202(d).
