ARTICLE III PURPOSE

The purpose for which the corporation is organized is: The Homefront Foundation is a not-for-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

The Homefront Foundation's purpose is to teach storytelling to service men and women as a coping mechanism for bearing the burdens of their profession. It provides education by teaching service members to share their stories in a public venue, thereby raising social consciousness of the rigors faced by our military brothers and sisters, thus allowing the community to learn from those stories.

To maximize the corporation's impact on current efforts, the corporation may seek to collaborate with other not-for-profit organizations that fall under the 501(c)(3) section of the Internal Revenue Code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, the corporation may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs in order to have a greater impact for change.
