Articles of Incorporation of Monarch Therapy Center, Inc.

Article I Name

Section 1. The name of this corporation shall be Monarch Therapy Center, Inc. The business of the corporation may be conducted as Monarch Therapy Center, Inc..

Article II Duration

Section 1. The period of duration of the corporation is perpetual.

Article III Purpose

Section 1. Monarch Therapy Center is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

Section 2. Monarch Therapy Center is committed to enriching family life through services that support growth and development of young children and their families. Monarch Therapy Center provides a comprehensive and faith based educational setting where all children regardless of need, gain the necessary developmental skills to achieve their greatest potential. Our focus is centered on restoring and actively rebuilding our community, one family at a time.

Section 4. Monarch Therapy Center is designated as a public benefit corporation.

Article IV Non-Profit Nature

Section 1. The Monarch Therapy Center is organized exclusively for charitable and educational purposes. No part of the net earnings of Monarch Therapy Center shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section 2. No officer or director of this corporation shall be personally liable for the debts or obligations of Monarch Therapy Center of any

nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

Section 3. No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 2. On dissolution, the corporation shall donate assets to a like non-profit organization with similar purpose/mission.

Section 4. No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

Section 5. Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Article V Board of Directors

Section 1. Monarch Therapy Center shall be governed by its board of directors. The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.
