The undersigned, acting as incorporation [s] of a Corporation pursuant to Chapter 617, Florida Statutes, adopt [s] the following Articles of Incorporation of such Corporation:

ARTICLE 1

Name

The name of the Corporation shall be:

The principle place of business of this Corporation shall be:

ARTICLE 2

PERIOD OF DURATION:

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence with filing with the secretary of state.

ARTICLE 3


PURPOSES, LIMITATIONS AND DISSOLUTION:

Section 2, purposes: The Purpose for which the Corporation is organized:

Philemon Worship Center is a New Testament Church, a non-denominational assembly of professing believers in Christ, who have been spiritually and water baptized to identify with Christ's death, burial, and resurrection We are Bible-Based, and practice all of the biblical instructions and ordinances as covenant believers, and follow the biblical guidelines for membership responsibilities and obligations as covenant members

Section 2.2 Limitations on actions: No part of the net earnings of the Corporation shall inure to benefit of, or be distributable to any member, director, officer of other private person, except that the Corporation shall be authorized and empowered to pay commensurate compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in section 2.1 of this article...No substantial part of the activities of the Corporation shall participate in, or intervene in {including the publishing or distribution of statements concerning political campaigns or candidates running for public office. Not with-standing any other provision of these articles. The Corporation shall not carry on any activities not permitted by the not-for-profit laws exempt from federal income taxes under section 501 [c] [3] of the Internal Revenue Code of 1986 as amended [or the corresponding provision of any future United States

Internal Revenue Law} or [b] by a Corporation, contributions to which are deductible under section 170 [ci [2] of the Internal Revenue Code of 1986 as amended {or the corresponding provision of any future United States Internal Revenue Law}...

Section 2.3 Dissolution: Upon the dissolution of the Corporation or the conclusion of its business affairs. The Board of Directors shall pay or make provisions for all payments incurred by the Corporation, and dispose of all of the assets of the Corporation exclusively to such charitable, scientific or educational organizations which are in existence and qualify as an exempt organization under section 501 [c] [3] of the Internal Code of 1986 as amended [or the corresponding provision of any future United States Internal Revenue Law], or if not, to such organization or organizations which are then qualified as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed by the Circuit Court of the County in which the principal office of the corporation is located and exclusively for the purposes of the corporation or to such organizations which are organized and operated exclusively for such purposes as the Circuit County Court shall determine.
