Articles of Incorporation

Bridge Community Church Cape Coral, Inc. Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be Bridge Community Church Cape Coral, Inc.

Article 2 Principal Office

Article 3 Purpose
