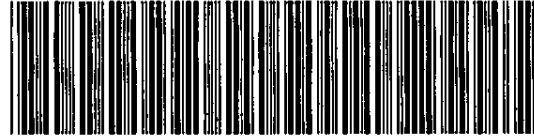

ARTICLES OF INCORPORATION

FREE INDEED MINISTRIES, INCORPORATED

STATE OF FLORIDA)

We, the undersigned natural persons of the age of eighteen years or more, all of whom are citizens of the State of Florida, acting as incorporators of a corporation under Chapter 617, Florida statutes, the Florida Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

Article I

The name of the corporation shall be: Free Indeed Ministries, Inc.

Article II

The principal office address is: 115-1 42nd Street, Mexico Beach, Fl 32410
The principal Mailing Address is: P.O. Box 13537, Mexico Beach, Fl. 32410

Article III

The objects, purposes and business of the corporation, which is organized exclusively as a Christian, charitable and eleemosynary corporation, are: To fulfill the great commission of Jesus Christ to go forth and spread the gospel to the whole world, to promote evangelism and discipleship, to support Christian ministries in the areas of preaching, counseling, teaching and music, to provide for the spiritual and physical needs of those in need and to use media or any other method deemed viable to promote the Gospel of Jesus Christ.

The corporation is a non-profit corporation. No part of the earnings of the corporation shall inure to the benefit of, or be distributable to, its members, officers, or other private persons, except that the corporation shall be authorized and empowered to make reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

The members of the corporation shall be the same persons as the Directors and shall consist of the persons named herein as Directors and such others as may be hereafter appointed by the Board of Directors of the Corporation.

ARTICLE IV

The officers shall be selected by the Board of Directors at its regular business meeting during the second week of March of each year. Should a vacancy occur due to the death, disability, or resignation of any of the officers, the Chairman of the Board shall select a replacement to fill that office.

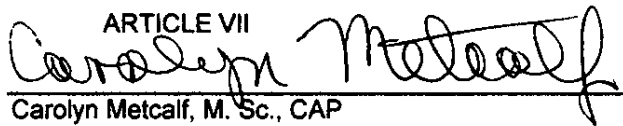
