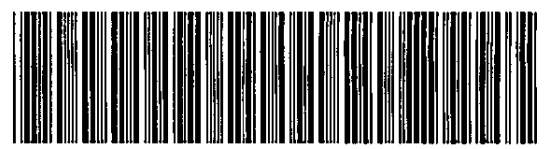

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the Country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organization, as said Court shall determine, which organized and operated exclusively for such purposes.
