similar to the terminating or dissolving corporation. The organization to receive the assets of the Ministerio Count on me Community Affairs Inc. hereunder shall be selected by the discretion of a majority of the managing body of the corporation and of it's members can also agree then the recipient organization should be selected pursuant to a verified petition in equity filed in the court of proper jurisdiction against Ministerio Count on Me Community Affairs Inc. by one or more of its managing body which verified petition should contain such statements as reasonably indicating the applicability of this section. The court upon a finding that this section is applicable will also let the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the state of Florida. In the event that the court shall find that this section is applicable at least generally but that there is no qualifying organization known to it which has a charitable purpose which at least generally includes a purpose similar to this Corporation then the court shall direct the distribution of its assets lawfully available for distribution to the treasurer of the State of Florida to be added to the general fund.

#### **Prohibited Distributions**

No part of the net earnings, or properties of this Corporation on dissolution or otherwise shall inure to the benefit of or be distributed to its members, directors, officers or other private persons are individuals, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose of supporting salaries to employees, organizations fees and charitable endeavors.

#### Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene including the publishing or distribution of any type of statements, endorsing any political campaign on behalf of or in opposition to any candidate for public office.

#### Other Prohibited Activities

Notwithstanding any other provision of these articles the corporations and not carry on any activities not permitted to be carried on 1) by a corporation exempt from federal income tax as an organization described by section 501 c 3 of the Internal Revenue code, or the corresponding section of any future federal tax code, or 2) by a corporation, contributions to which are deductible under Section 170 c 2 of the Internal Revenue code, or the corresponding section of any future federal tax code.
