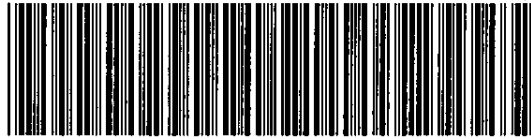

ARTICLES OF ORGANIZATION OF ANANEOO, INC.

ARTICLE I. NAME

We, the undersigned certify that we have joined ourselves together as Ananeo, Inc., an Agricultural Cooperative Marketing Association, for the purpose of forming a nonprofit corporation under the laws of the State of Florida, Chapters 617 & 618, providing for the formation, rights, privileges, and immunities of a corporation not for profit.

ARTICLE II. PRINCIPLE OFFICE

The corporation shall have its principal office at: 6650 Havana Highway, Town of Havana, County of Gadsden, State of Florida, 32333

ARTICLE III. PURPOSES

Ananeo, Inc. is organized under the laws of the State of Florida, Chapters 617 & 618, for the purpose of engaging in any cooperative activity in connection with the producing, marketing, or selling of organically grown agricultural products; or with the growing, harvesting, preserving, drying, processing, canning, packing, grading, storing, warehousing, handling, shipping, or utilizing such products; or the manufacturing or marketing of the byproducts thereof; or in connection with any of the activities mentioned herein, the manufacturing, selling, or supplying of machinery, equipment or supplies; or in the financing of any of the above-enumerated activities; or in performing or furnishing business or educational services, on a cooperative basis for those engaged in agriculture as bona fide producers of agricultural products or in any one or more of the activities specified herein; or to provide green burial space and services for members of this association.

ARTICLE IV. POWERS

Ananeo, Inc. shall have the following powers:

- (1) To act as the agent of the membership in any of the above-mentioned activities;
- (2) To purchase or otherwise acquire, to hold, own, and exercise all rights of ownership in, and to sell, transfer, pledge, or guarantee the payment of dividends or interest on, or the retirement or redemption of shares, of capital stock, bonds, or other obligations of any corporation or association, engaged in any directly or indirectly related activity, or in the producing, picking, hauling, packing, shipping, handling, warehousing, financing, canning, preserving, processing, manufacturing, utilizing,

marketing, sharing, donating, or selling of any of the products handled by the association, or any byproducts thereof;

(3) To establish reserves and to invest the funds thereof in bonds, or in such other property as may be provided in the bylaws;

(4) To buy, hold, and exercise all privileges of ownership over such real or personal property, as may be necessary or convenient for the conduct and operation of any of the business of the association or incidental thereto;

(5) To sell, convey, share, trade, donate, and transfer all of the produce of the association; provided such activity shall be consented to by not less than two-thirds of its members which consent shall be given either in by laws, writing, or by vote.

(6) To establish, secure, own, and develop patents, trademarks, and copyrights;

(7) To do each and everything necessary, suitable or proper for the accomplishment of any one of the purposes, or the attainment of any one or more of the objects herein enumerated, or conducive to or expedient for the interest or benefit of the association, and to contract accordingly; and in addition, to exercise and possess all powers, rights, and privileges necessary or incidental to the purposes for which the association is organized or to the activities in which it is engaged, and any other rights, powers, and privileges granted by the laws of this state to corporations for profit, except such as are inconsistent with the express provisions of this chapter; and to do any such thing anywhere;

ARTICLE V. PERIOD OF DURATION

This agricultural cooperative marketing association shall exist in perpetuity or until dissolved in a manner provided by law or as provided in the member adopted bylaws.

ARTICLE VI. DIRECTORS

ARTICLE VII. MANNER OF ELECTIONS

Directors shall serve five year terms and be elected by a majority vote of the Members as described in the member adopted By Laws of Ananeo Inc.

ARTICLE VIII. MEMBERSHIP

The association shall not have capital stock but shall admit applicants to membership in the association upon such uniform conditions as may be prescribed in its bylaws. This association shall be operated on a cooperative basis for the mutual benefit of its members as producers. Membership in the association shall be restricted to producers and associations of producers who shall patronize the association. The voting rights of the members of the association shall be equal, and no member shall have more than one vote upon each matter submitted to a vote at a meeting of the members. The property rights and interests of each member in the association shall be equal and the net proceeds from the business of the association shall be allocated to member-patrons in equal proportion.

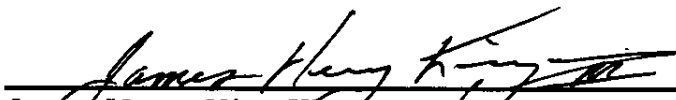
ARTICLE IX. AMENDMENT

ARTICLE X. INITIAL REGISTERED AGENT

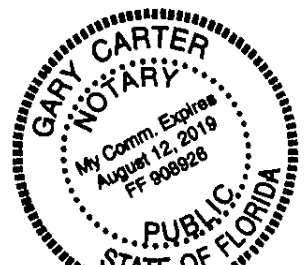

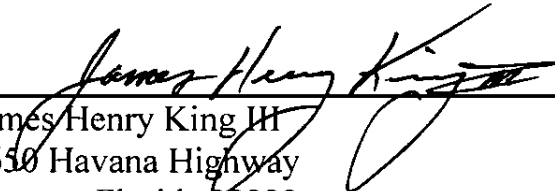
